

FOURTH AMENDMENT TO MASTER DEED OF RIVERWALK COMMONS

Reference is made to the Master Deed of Riverwalk Commons, ("Condominium") recorded with Norfolk County Registry of Deeds on February 13, 2003 as instrument no. 35128, as amended by First Amendment to Master Deed recorded with said Deeds on April 8, 2003 as instrument no. 81924, as further amended by Second Amendment to Master Deed recorded with said Deeds on May 20, 2003 as instrument no. 118006 and as further amended by the Third Amendment to Master Deed recorded with said Deeds on August 8, 2003 as instrument no. 188285 ("Master Deed").

WHEREAS, OHC Bird Pond LLC ("Declarant") has, in Section 16 of the Master Deed, reserved the right to add additional units to the Condominium; and

WHEREAS, Declarant intends to amend the Master Deed by submitting additional units to the Condominium as phase 5 thereof.

NOW, THEREFORE, the Declarant hereby amends the Master Deed, as follows:

1. Declarant hereby declares phase 5 of the Condominium consisting of three buildings, each containing one Unit. The Condominium now consists of a total of fourteen buildings, each containing one Unit.

2. The Units submitted to the Condominium with this Fourth Amendment to Master Deed as a part of phase 5 are, as follows:

3. As a result of the addition of the Unit, the last paragraph of Exhibit B is amended, as follows:
